1. Call to Order (10:00 AM) by Chair Mary Lynn McKenna

2. Previous Meeting Minutes

Update on grant reimbursement and match for activities from April 1-September 30th.

Gayla Hess provided a copy of the reimbursement request with final numbers (attached) pointing out the HRB match of \$2,907.06 is the value for the 110 hours donated by the group. Members individually spent 15-50 hours of time during the reporting period.

Lynette Foulger said she'll work on tracking her HRB time better, and Rose Nyman shared that she plans to turn in donated service sheets monthly.

Rose Nyman made a motion to take from the table photo donations discussion. Lynette Foulger seconded. Motion passed 5-0.

Mary Lynn McKenna provided a recap to the members who were absent at the last meeting noting that this was a result of comments from the Smelterman's Day event.

Rose Nyman shared photos that she had purchased and asked if all donations would be accepted or if the group would screen for photos that had identified people and places. Lynnette Foulger asked if the purpose would be to collect for a digital photo album. Rose envisioned making the copies available to the public and Lynnette volunteered to help. Gayla Hess spoke of concerns for where donations would be kept, proper storage, and if any documentation would be required from the donor.

Bob Wren thought the group could help folks digitize their photos, spoke of the need for a climate-controlled space, and the need to identify people and approximate dates to be able to properly tag and find photos. Terry LaValley agreed with the need digitize any collection. Bob Wren asked if a cloud subscription could be an eligible expense or if a scanner could be applied through grants. Mary Lynn thought everyone liked the idea, but that more information would be needed. Bob Wren moved to table pending further information. Terry LaValley seconded and the motion to table passed 5-0.

4.1 Grant Opportunities

Montana History Foundation grant cycle opens October 31st with an application deadline of January 13, 2023, <https://www.mthistory.org/grants/>

Montana Historical Society Outreach Education – **Hidden History Montana**. Pilot program will select 10-12 local museums, historical societies, or preservation commissions to offer a rolling series of one-day summer events where a town's (or county's) hidden historic places are open to the public for self-guided tours. Hidden History sites are generally located in homes, commercial and civil buildings, or on private land that is **not normally open** to the public. MTHS will partner with selected organizations to provide tour planning best practices, print, website, and social media promotional support, and a small stipend for event supplies. Applications to the program are due by Jan. 1

Gayla Hess told the group that a new or an updated survey might be eligible for the Montana History Foundation grant. Mary Lynn McKenna thought the Hidden History could be interesting.
