Commission Chair Hart called the meeting to order at 7:02p.m. and the Pledge of Allegiance was recited.

UNFINISHED BUSINESS

- A. Petition Submitted by the St. Timothy's Memorial Chapel Committee to Abandon a Portion of Cable Mountain Road along the front (southwest side) of St. Timothy's Chapel

CEO Ternes Daniels stated Commissioner Vermeire did an excellent job on his report and noted staff thoroughly explained the new alignment. She encouraged approval of the petition.

Commissioner Lux-Burt moved to approve the petition submitted by the St. Timothy's Memorial Chapel Committee to abandon a portion of Cable Mountain Road along the front (southwest side) of St. Timothy's Chapel; seconded by Commissioner Mulvey.

Commissioner Vermeire recommended adding to the motion the addition of a sign at the top of the new road directing people to St. Timothy's.

Commission Chair Hart noted the addition of the sign is the responsibility of the developer and not part of the petition to abandon the road and, therefore, should not be part of the motion.

Motion carried unanimously.

Commission Chair Hart suggesting placing this item on the next Business Meeting Agenda.


CEO Ternes Daniels concurred with this and stated it will be great to have Commission representation on this board.

PUBLIC COMMENT


No public comment.
